

CloudResearch National Survey | November 9, 2020

These data are from an online survey conducted by <u>CloudResearch.com</u> on November 9^{th} , 2020 using Prime Panels. A total of 824 respondents over the age of 18 completed our survey. The sample was weighted using iterative proportional fitting ("raking") to match the ACS 2018 5-year estimates on gender, age, race, ethnicity, education, and income. The margin of error for the unweighted sample is ± 3.4 percentage points; margins of error are larger for subgroup estimates.

Note: The presentation order of the questions was randomized for each survey.
